In recent years, it has become increasingly important for all of us to celebrate, value, and strengthen our connections to each other and the world around us. Artists are asked to create work for this exhibition that explores this idea of connection. Artworks will feature traditional media such as painting and drawing but alternative approaches to mixed media are also encouraged.

ELIGIBILITY & ENTRY FEE:

Open to all artists residing in Florida. An entry consists of 1 to 3 artworks. Non-refundable Entry Fee is \$15.00 for one entry and \$30.00 for 2 or 3 entries for Alliance for the Arts members - \$20.00 for one entry and \$40.00 for 2 or 3 entries for nonmembers. Alliance for the Arts memberships are \$55.00 and are good for one year.

SPECIFICATIONS:

Medium: Oil, acrylic, watercolor, mixed media, collage and photography. All artwork must be at least 18x24 framed but not to exceed 40 inches in any direction. If framed with glass, the glass must be non-glare. All artwork must be wired, ready to hang and delivered to the Alliance labeled with the following information: Artist Name- Title – Medium – Price

LIABILITY

If artwork is juried in, artists are responsible for all shipping costs. Every effort will be made to handle with care, including protection from loss. Alliance for the Arts and Lee County Port Authority will not be liable for loss or damage caused or occurring while work is exhibited or during shipping. Submission of any artwork constitutes an agreement to all conditions of this entry form, including schedule and permission to photograph for publicity purposes. Signature on the entry form is an agreement to these conditions.
